About the Organizer	<p>Shanghai Customs University is the only full-time undergraduate institution directly under the General Administration of Customs of China, evolved from the Shanghai Customs School established in 1953. Through multiple phases of rapid development, the institution was upgraded to an undergraduate University in 2007, became a degree-awarding unit for master's degrees in 2018, and was included in the list of doctoral degree cultivation units in Shanghai in 2022, making it the highest education institution in China's customs system. The University's core mission is to cultivate high-quality customs management talent; its customs management program was certified by the World Customs Organization under the PICARD standards in 2018, establishing it as a benchmark in the global customs education field.</p> <p>The University comprises eight teaching units, including the University of Customs and Public Administration and the Customs Inspection and Quarantine Department. It offers 12 undergraduate programs, such as customs management, international business, and law, as well as master's degree programs in national security as a first-level discipline and professional master's degrees in public administration, taxation, and more. Among the faculty, 96% hold master's degrees or higher. The research team focuses on cutting-edge fields like customs risk management and international cooperation, with unique research platforms such as the Customs Law Research Center providing theoretical support for customs reform. The main campus is located in the Pudong New Area of Shanghai, covering 521 acres and equipped with modern teaching buildings, a digital library, and international-standard sports facilities. The Lingang International Campus is dedicated to conducting cross-border educational cooperation, while the Suzhou branch focuses on specialized training tasks.</p> <p>As a university co-established by the General Administration of Customs and the Shanghai government, the University deeply serves national strategies and has long been responsible for training mid-to-senior-level officials in the Chinese customs system. It is also entrusted by the World Customs Organization and the Ministry of Commerce to provide capacity-building programs for customs officials from developing countries. The University maintains collaborations with customs institutions from over 40 countries, regularly hosting international academic forums to promote innovations in global customs governance. In 2024, a new digital economy master's degree program will be established, further strengthening the construction of the national security discipline and expanding the dimensions of talent cultivation.</p> <p>The University adheres to the educational philosophy of 'patriotic ambition and open-minded scholarship,' committed to fostering versatile talents with both professional skills and international perspectives, continuously contributing innovative forces to the customs cause in the new era, and steadily advancing toward the goal of becoming a first-class higher education institution with distinct customs characteristics and international influence.</p>
