New Board Appointed to Lead the Telecommunications Authority of Trinidad and Tobago

The Ministry of Public Administration and Artificial Intelligence has appointed a new Board of

Directors to the Telecommunications Authority of Trinidad and Tobago (TATT). The installation

ceremony was held on Friday, 10 October 2025, at the Ministry's 14th Floor Conference Room,

Tower C, International Waterfront Centre, Port of Spain.

At the helm of the newly appointed Board is Mr. Cris Seecheran, Chairman, supported by Mr.

Jerome Khan as Deputy Chairman. They will lead a diverse and accomplished team entrusted

with advancing the Authority's mission to strengthen Trinidad and Tobago's communications

and broadcasting sectors. The full Board includes Mr. Mentor Baptiste, Dr. Justin Koo, Ms.

Avanti Supersad, Mr. Russel Romero, Mr. Suresh Boodoo, Mr. Dion Khan and Ms. Danielle

Pounder with each bringing a wealth of expertise in telecommunications, law,

entrepreneurship and education.

In congratulating the new Board, Minister of Public Administration and Artificial Intelligence,

Senator the Honourable Dominic Smith, emphasised the critical role of TATT in ensuring that

all citizens benefit equitably from technological advancements. Minister Smith encouraged

the Board to adopt a three-fold approach: focus on core regulatory functions, explore the

potential of artificial intelligence to enhance operations and lead with empathy thereby

addressing the real pain points experienced by citizens.

Drawing on Steve Jobs' "signal versus noise" theory, the Minister urged members to dedicate 80% of their time to purposeful execution, while remaining agile and innovative in their approach. He reminded the Board that technology must never overshadow humanity and that the Authority's work must always reflect the Government's commitment to placing people at the centre of progress.

TATT, as an independent regulatory body, plays a vital role in overseeing the telecommunications and broadcasting sectors. Its mandate includes managing spectrum and numbering resources, setting service standards, promoting sector liberalisation and creating investment to ensure nationwide access to reliable and affordable communications services. Under the leadership of this new Board, the Ministry is confident that TATT will continue to uphold transparency, fairness and excellence - driving innovation and sustainable growth in a sector that is essential to our national development.
