INVITATION TO REGISTER AND PREQUALIFY NATIONAL DIGITAL READINESS ASSESSMENT AND ROADMAP FOR TRINIDAD AND TOBAGO

The Ministry of Public Administration and Artificial Intelligence (MPAAI), in alignment with the Government of the Republic of Trinidad and Tobago's digital transformation agenda, is undertaking the development of a National Digital Readiness Assessment and Roadmap. This initiative builds on the baseline established during the March 2022 assessment conducted with support from the UNDP, which benchmarked the nation's progress across five core pillars of digital readiness: people, connectivity, government, regulation, and the economy. The 2022 assessment identified notable advancements in mobile penetration and ICT infrastructure, while also highlighting key gaps, including limited rural broadband access, disparities in digital literacy, the early stage of e-Government adoption, and the absence of a comprehensive national digital identity framework.

The Ministry of Public Administration and Artificial Intelligence (MPAAI) is inviting a Consulting Firms to register and prequalify for **National Digital Readiness Assessment and Roadmap for Trinidad and Tobago**.
